## V E N D O R   R U L E S

1. All vendors must unload and park in vendor parking before setting up.
2. 20X20 spaces are allowed a maximum of 2 vehicles during set-up and take-down, one in the space and one in the aisle.  
10X20 spaces are allowed a maximum of 2 vehicles during set-up and take-down, only one at a time in the aisle.  
All other spaces are allowed a maximum of one vehicle during set-up and take-down.
3. Customer parking is a priority. All vendors and their staff must park their vehicles in vendor parking, or in their 20X20 space.
4. No vendor vehicles will be allowed in the aisles after 8:50AM.
5. All vendors must set up within designated space lines painted by MTP staff.
6. No drug paraphernalia, weapons, replicas, adult material, food or drinks may be sold. Do not bring your pets. The sale of counterfeit or stolen goods and the sale or use of drugs is prohibited and is subject to loss of selling privileges, arrest and prosecution.
7. An adult must supervise any children under 15.
8. All trash must be picked up from each vendor space and disposed of properly before leaving the market on time.
9. All vendors must be out of the market before 7:00PM. Vendors in the Food Court and Grass Areas must be out by 6:45PM.
10. The market closes promptly at 5PM. No customers are allowed in vendor booths after 5PM.  
**ANY VENDOR VIOLATING RULES 1-10 WILL BE FINED \$50.**  
**SECOND VIOLATIONS WILL RESULT IN PERMANANT LOSS OF SPACE**
11. If a vendor has not checked in by 7:30AM, they are considered a no-show and their space will be sold through our stand by line.
12. Vendor bookings take place from 12pm-2pm in the food court for the following Sunday; 2:00-2:30PM is for general questions and information. Permanent Vendors may also pay by check with an envelope we provide at check in. We will bring your receipt to your booth. Permanent vendors must pay by 2pm or lose their space for the week. Any space not booked by 2pm must be paid for by the following Wednesday or will be sold at management's discretion.

### IN GENERAL

The admission price for customers is \$2.00. Admission for children under 12 is free. We run an ad with a coupon in the West Coast Peddler. We also have a coupon on our blog at [www.melrosetradingpost.org](http://www.melrosetradingpost.org). We are on Twitter, Facebook, Instagram, and Pinterest.

If you have someone coming to help you with vending, they need to leave their name at the admission gate or they will have to pay to enter. There is no vendor parking allowed on surrounding streets- all vendors must use vendor parking lot. If we find a vendor or vendor staff vehicle parked on the street they will lose their selling privileges.

If you do not have a California resale number and are not an occasional seller (2 or less times selling) you may not sell at this event. A resale number may be obtained at any Board of Equalization office. You can contact them through their website: [www.bofe.gov](http://www.bofe.gov) or by looking them up in the phone book, under "State Government". A resale permit with our physical address added as an additional selling location is required for permanent vendor consideration. Our physical address is 7850 Melrose Ave., Los Angeles, CA 90046.
